

## REPORT

### On the Key Performance Indicators of the Anti-Corruption Compliance-Control Department at Alisher Navo'i Tashkent State University of Uzbek Language and Literature for 2025

1. During the third quarter of 2025, the Anti-Corruption Compliance-Control Department of TSUULL organized over 50 events, including roundtable discussions, preventive measures, meetings, and seminars on anti-corruption topics. In the same quarter of 2024, 36 such events were conducted. This indicates a 70% increase in anti-corruption activities compared to the previous year.

2. A sociological survey titled “**Satisfaction of Parents with the Quality of Educational Services**” was developed in collaboration with faculty from the Sociology Department. The survey was conducted among 1,560 students during the winter and summer examination periods to assess education quality. According to the results:

- 90% of students rated lessons as excellent, 7% as satisfactory, and 3% as below standard.

- Regarding the question of whether professors or other staff engaged in corrupt practices during lessons or exams, all respondents reported either that such cases did not exist or that they had not encountered them.

3. On December 21, 2024, based on Contract No. N1974935 with **GOOD BEST FAST LLC**, the University filed a lawsuit with the Tashkent Interdistrict Economic Court on August 29, 2025, because the company failed to deliver goods worth 28,500,000 UZS as specified in the contract.

4. From January to November 2025, four inspections and monitoring activities were carried out to prevent corruption and conflicts of interest. During these inspections, financial errors and deficiencies amounting to 9 million UZS were identified. In the area of public procurement, a total of 566 contracts were reviewed, 15 counterparties were studied, and 120 public procurement contracts were examined.

5. During the first stage of master's studies, students **Kenjaeva Dildora Muxtoriqizi** and **Abdunabieva Barno Abdirasil qizi** submitted medical certificates that raised suspicions. Verification of the certificates issued by the Qibray District Family Polyclinic No. 71 (Certificate No. 01TSh 016217825, April 7, 2025) and Yangiyo'l District Family Polyclinic No. 69 (Certificate No. 12TB 006305425, April 30, 2025) was carried out according to the Guidelines of the Ministry of Health of the Republic of Uzbekistan (Order No. 25, March 20, 2015) on the issuance of disability certificates.

- The head of the Yangiyo'l District Medical Association confirmed on June 10, 2025 (Certificate No. 359) that the certificates were **not authentic**.

○ Based on this, the students were suspended from classes and informed of criminal liability under **Article 228 of the Criminal Code of Uzbekistan** for forgery, use, or sale of official documents, seals, or blanks.

○ Both students admitted their actions voluntarily and were expelled from the University by the Rector's order No. 03-353 dated June 16, 2025. *(Certificates, letters, and orders are attached.)*

6. In accordance with the tasks set out in **Resolution No. 17 of the National Anti-Corruption Council of Uzbekistan**, the University's Anti-Corruption Compliance-Control Department developed a monitoring plan to instill integrity values and legal immunity against corruption among students. From May to November, students were registered to receive training via the "**Anti-Corruption Virtual Academy**" electronic platform.

○ To date, 1,600 students and 18 staff members have participated in the special anti-corruption course offered through the platform. *(Contracts and certificates obtained by participants are attached.)*

7. The University maintains ongoing parental and public oversight, regularly discussing feedback and other important information in the anti-corruption process.

○ The Compliance-Control Department has informed all staff of the criminal liability for corruption-related offenses under the Criminal Code of Uzbekistan, including:

- Article 167, Clause D: **Misappropriation by Abuse of Office**
- Article 168: **Fraud Using Official Position**
- Article 192: **Excessive Receipt of Bribes**
- Article 210: **Giving Bribes**
- Article 211: **Receiving Bribes**
- Article 212: **Mediation in Bribe Giving or Receiving**

○ All department heads, staff, and faculty signed guarantees acknowledging these responsibilities. During the reporting period, no cases of corruption or liability were identified among faculty or staff.
