Fight against corruption by "Compliance control" department**

Tashkent State University of Uzbek Language and Literature fights against corruption led by the Department of Management of the "Compliance Control" system promotes the transparency of the activities of university through mass media and social networks according to the plan approved in February of this year.

In order to ensure and strengthen public control, the *@toshdutaу\_no\_korrupsiya\_bot* channel was launched to receive anonymous messages about corruption cases with the institute's employees and students. In addition, during the month of February, in accordance with the anti-corruption plan, a roundtable discussion on the topic "Corruption-free sphere" carried out under the slogans "*Let's fight corruption together*", "*Education without corruption*".

Also, according to the plan, more attention was paid to the fight against corruption in order to take the intermediate control test exams of students in higher education institutions, to restore their studies, and to control the processes of hiring and appointing teaching staff to the institute.

In order to detect the absence of corruption or any type of crime the questionnaire was created and announced to the team of university and staff.

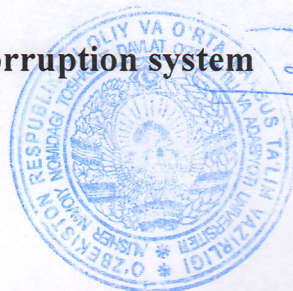
Based on the action plan of the department in the institute, the Ministry of Justice issued a decree "On measures to create an environment of intolerant attitude against corruption, to sharply reduce corrupt factors in state and community management, and to expand public participation"

Widely promoting the essence and importance of Presidential Decree No. PF-6257 of July and Resolution No. PQ-5177 of July 6, 2021 "On additional measures to effectively organize anti-corruption activities" and for the purpose of clarification, in February of this year, more than 10 preventive measures on the topic "Education without corruption" were carried out among professors and teachers of the institute.

Preventive talks on prevention of corrupt situations were held among professors and teachers. For example, on February 21, 2022, a roundtable discussion on the topic "**Corruption-free sphere**" was held by the Department of Management of the University's anti-corruption "Compliance-control" system for students of the 1st year of part-time education of the University. A close interaction with the students was held in the roundtable discussion. It was emphasized to students that preventing corruption in education is the main duty of every citizen.

As a result of interviews with part-time students at the university in February 2021, M. Dehkonova and H. Radjabova were accused of taking 2,000 (two thousand) soums from part-time students for a membership certificate given free of charge by.

When conducting studies on this situation, ARM librarians M. Dehkonova and H. Radjabova admitted that they tried to get this charge. This situation was thoroughly investigated by the anti-corruption department of the university, and the employment contract with M. Dehkonova and H. Radjabova was canceled. The Fine (*HAYFSAN*) was given to the director of ARM Tursunova Shokhista for the origin of this situation and for taking a cold look at her work by weakening the control.

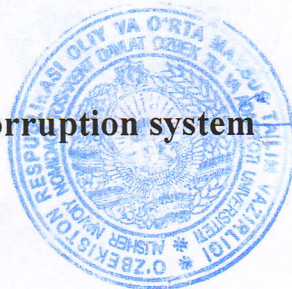

During 2021, Tashkent State University of Uzbek Language and Literature...  
When studying the cases of payment-contract receipts by university students with the accounting department of the university, including the payment of contract amount through receipts No. 2431, registered in February, it became known that according to the regulations, payment orders are accepted into accounting, checked, approved and accepted through the "UzASBO" program.

A. Nasriddinov, the head of anti-corruption control department, visited Ahangaran district in order to give a presentation on vulneralbe topic regarding corruption on April 28. A.Nasriddinov described university program which describes why and how we work with anti-corruption, and gave a brief description on the most common forms of corruption, such as bribery, kickbacks, facilitation payments, conflicts of interest, probation of payments to public officials, fraud, and extortion.

He also mentioned that this project supports the 2030 Agenda for Sustainable Development and its 17 Sustainable Development Goals (SDGs). SDG 16 specifically deals with "Peace, Justice and Strong Institutions," and target 16.5 of this goal is "*Substantially reduce corruption and bribery in all their forms.*"

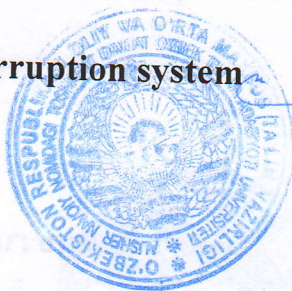

During 2021, Tashkent State University of Uzbek Language and Literature Department of Combating Corruption "Compliance Control" system management department took appropriate measures based on the plan to ensure the implementation of Order No. 281 of OTV dated 28.06.2021.

In particular, 17 preventive measures on the topic "Prevention and fight against corruption" in the higher educational institution to prevent and fight against corruption among university employees, professors and students based on the action plan of the department, 30 round-dialogues, 7 seminars, 19 educational events, 2 contests were organized, and 200 professors-teachers, 22 tutors, 2500 students-young people were included in these preventive events and round-dialogues.

In the academic lyceum under the university's control, roundtable discussions on the topic of **"Prevention and fight against corruption"** were conducted by the "Compliance Control" System Management Department.

**Anonymous questionnaires** were conducted among the students of the Faculty of Applied Philology, and the rector of the university was informed about the results. Preventive talks on prevention of corrupt situations were held among professors and teachers. **@Yoshlar\_masalalari\_bot** and **@toshdotau\_no\_korrupsiya\_bot** channels were established at the university to receive applications from all students, professors, teachers and staff.

Based on the plan of measures implemented in 2021, the purchases made at the institute, the monitoring of tenders, and the regular inspection of counterparties were controlled, and an opportunity was created to constantly monitor all operations performed in this direction through the relevant **UzASBO** program.

Based on dialogues with students, professors and staff, roundtable discussions and opinions expressed in the questionnaire, more attention should be paid to the fight against corruption, simplification of admission to master's degrees in higher education institutions, students' education.

It is necessary to introduce all checks in the computerized system, removing bureaucratic obstacles, and to monitor the processes of hiring and appointing teaching staff at the university.
